Average annual total return quotations reflect the percentage change between the beginning value of a static account in the Fund and the ending value of that account measured by the current net assets value of the Fund, and assume that all dividends and capital gains distributions during the stated period were reinvested in shares of the Fund when paid. Average annual total return is calculated by finding the average annual compounded rate of return of a hypothetical investment that would equate to the initial amount invested to the ending redeemable value of such investment.
